INSTRUCTIONS- Fill one form out for **EACH** dog registered. Send the form and the ANNUAL FEE of \$10 for **EACH** dog submitted **PLUS** a \$10 fee for the key fob and shipping to: Tiffin Bark Park Registrations, P.O. Box 611, Tiffin, OH 44883-0611. Checks should be made payable to FRIENDS OF THE TIFFIN BARK PARK. Example--**Registering 1 dog plus key fob = \$20 Registering 2 dogs plus key fob = \$30**

Requirements for registration into the Tiffin Bark Park are as follows: Current 1 yr. or 3 yr. Rabies vaccination, current 1yr. DH(L)PP or 3 yr. DHP, Bordetella Vaccination and have a fecal performed within the past 3 months. If your dog cannot receive regular vaccines, please provide proof of protective titer levels. Canine Influenza (Bivalent) is HIGHLY RECOMMENDED. Dogs MUST be vaccinated by a veterinarian to enter into the Tiffin Bark Park for their own protection and for the protection of other dogs.

I understand that my dog(s) and I may be subject to injury from other dogs because of natural and man-made hazards or due to the strenuousness of the activities. I hereby waive and release the City of Tiffin, the City of Tiffin Dept. of Parks and Recreation, the Tiffin Bark Park, the Friends of the Tiffin Bark Park, and all of the above agency's employees or volunteers from any and all liability of any nature, for the injury or damage I or my dog(s) may suffer, including specifically, but without limitation, any injury while on or within the general area of the dog park grounds or while participating in any dog park activity or function. I further agree to indemnify and hold harmless the City of Tiffin, the City of Tiffin Dept. of Parks and Recreation, the Tiffin Bark Park, and the Friends of the Tiffin Bark Park and their employees or volunteers from any and all claims by any member of my family or any other person accompanying me to the dog park, or while on the grounds or the surrounding area thereto as a result of any dog, including my own.

RULES OF THE TIFFIN BARK PARK*

- Dogs must be licensed. Healthy and current on all vaccinations as detailed on the reverse side of this applications
- Dogs must be under reasonable control by their owners/handlers at ALL times when in the park
- Dogs must be leashed when outside the perimeter of the park
- This is an OFF-LEASH dog park. It is recommended that your dog is off leash upon entering the park.
- Owners/handlers MUST clean up after their dogs' "deposits" IMMEDIATELY.
- ONLY registered owners/handlers are permitted within the park
- **Children under the age of 8 are NOT allowed in the park at any time**
- Children between the ages of 8-14 must be under the close supervision of an adult 18 years of age or older
- No more than 2 dogs per handler/owner are allowed in the park at any given time
- ABSOLUTELY NO FOOD in the park
- NO dogs in heat
- No AGGRESSIVE dogs
- No puppies under 4months old
- NO glass containers
- Take toys home that you bring. Toys left may be disposed of without warning.
